## \$279000 1BD & 2BD Condos in Eco-Friendly, LEED Certified Building! (River North) (map)

A posting in the housing section of the Chicago Craigslist trumpets the availability of one- and two-bedroom condos in an "Eco-Friendly, LEED Certified Building." The promotional Web site at <http://www.lwestone.com/building/design.html>, for the building lists "LEED-Certified" as one of the "eco-features."

The problem is the 14-story high-rise, called the 9 West Erie, has not yet been built, and therefore cannot be certified by the U.S. Green Building Council's Leadership in Energy and Environmental Design, or LEED, program — the nationally recognized third-party certification process for the construction of "green" buildings.

Unfortunately, A building must be fully constructed before it can achieve the LEED designation.

While the Craigslist posting and the Web site for 9 West Erie provide clearer language in the fine print (the building is "pursuing" LEED certification, they say, under their headlines), the example illustrates how the LEED moniker can be misrepresented in real estate marketing materials.

A recent [article posted by the realty information service CoStar Group](#) investigates the increase in dubious LEED claims and cites several examples of projects being promoted as LEED-certified while still in the early stages of development or construction.

"Misleading statements about LEED, which appear in marketing materials, press statements and even securities filings, are a form of greenwashing," the article states. "And according to property professionals who have encountered it, the problem is becoming worse as the green movement has grown in popularity."

For those who want to check if a building is as green as advertised, the Green Building Council maintains an online LEED registry at <http://www.usgbc.org/LEED/Project/CertifiedProjectList.aspx>.

1. Yes, there is an LEED-certified gas station. No it does not sell bio diesel, but regular gas.
2. Justin Timberlake's golf course has a LEED-certified lodge, but what about the chemicals used to keep the greens green?
3. LEED certified Water Bottling Plants.....Nestle's Pure Life, Ozarka, Arrowhead, Ice Mountain, and Deer Park water bottling plants all have LEED certifications, but when you think about the plastic bottle garbage they generate you wonder if their LEED certifications are actually eco-friendly

6. Antilia Tower - Mumbai, India, often cited as one of the greenest buildings on the planet, and probably not LEED certified because it is no in the U.S., it is however the home of only one family, and built in one of the most overcrowded cities on the planet.
7. Civic Parking Garage Santa Monica, LEED certified to encourage using your car instead of public transit?
8. Vacation Home Development - Las Vegas, Nev. Wow, A LEED certified Vacation Home. If we are going to be sustainable, do you really need more than one home?
9. Spaceport America - New Mexico, LEED certified building, O.K. So how is personal space travel in the \$250,000 range for a ticket, sustaining the environment, when it uses up such a huge amount of resources for one space flight. This is truly the rich pretending to be eco-friendly.
